### **INSTRUCTIONS FOR USE**

- Pour waste formalin into a sturdy nonleaking container with enough headroom to add NeutraGreen<sup>TM</sup> at a ratio of 1 part NeutraGreen<sup>TM</sup> to 4 parts formalin.
- 2. Add NeutraGreen™ in the proper ratio.
- 3. Wait 2 hours and test for neutralization. If less than 1% aldehyde present product is ready to be discarded. All formalin vapors should be noticeably gone.
- 4. If desired, it is recommended to perform testing to ensure that product has been neutralized.
- 5. Once formalin is neutralized, material may be disposed of as non-hazardous and non-toxic material with zero vapor exposure. Dispose of waste material according to all local, state and federal rules and laws.

Technical Note: dispose down sanitary sewer if permitted.
